HEALTHTRUST Discount Code: FAN # 2000931

- A FAN is a unique number that identifies your account throughout all AT&T Mobility markets. Its main function is to define your employee discounts and services. You are required to know your FAN when ordering service or having a line enrolled in the program to get the company discount. The FAN for all HealthTrust Employee members is 2000931.

Contract Benefits for Personal Employee Lines (paid for by employee)

FAN # 2000931

- **22% service discount**
 - **Mobile Share Plans** – The discount is applied to the Monthly recurring charge for the Data package on the mobile share plans; however the 300MB and 2GB plans are **not eligible** for the FAN discount because they do not meet the monthly rate plan minimum of \$30.01. The per line monthly access device fee will **not** receive the discount.
 - ATT Mobility Nation Voice Plans
 - ATT Mobility Data Plans (\$15 and \$30 consumer data plans not discountable)
 - **Not discount eligible**: Senior Nation Plan, Family talk secondary lines, business shared secondary lines, unity plans/combined billing, Unlimited Voice plans, Original iPhone and other optional add-on features (like text messaging, roadside assistance or insurance) are not discountable features/plans.
- **20% off Equipment discount**: or promotional pricing, whichever results in the lower price to the individual. Only 2 year contract pricing options apply. ATT NEXT plans do not allow for the equipment discount.
- **25% Accessory discount** : or promotional pricing, whichever results in the lower price to the individual when ordered via the online Premier Store website
- **Waived New Activation fee** on orders **placed thru the Premier Store Web site**. You will pay this fee at retail stores and orders placed over the phone.
- **Waived Upgrade fee** on orders **placed thru the Premier Store Web Site**. You will pay this fee at retail stores and orders placed over the phone.
- **2 Year service agreement required.**
- **Included features on voice plans**:
 - Basic voice mail, caller id, call waiting, call forwarding and three party calling
