

**SUMMARY ANNUAL REPORT FOR
ARDENT HEALTH SERVICES WELFARE BENEFIT PLAN**

This is a summary of the annual report of the Ardent Health Services Welfare Benefit Plan, a health, life insurance, dental, vision, temporary disability, prepaid legal, long-term disability, severance pay and death benefits plan (Employer Identification Number 62-1743438, Plan Number 501), for the plan year 01/01/2021 through 12/31/2021. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Ahs Management Company, Inc. has committed itself to pay certain Health, Prescription drug, Dental, Flexible spending account, Vision, EAP, Temporary disability, Long term disability, Severance pay claims incurred under the terms of the plan.

Insurance Information

The plan has insurance contracts with Life Insurance Company Of North America And Metropolitan Property And Casualty Insurance Co. to pay certain Life insurance, Temporary disability, Long-term disability, Accidental death & dismemberment, Critical illness, Legal claims incurred under the terms of the plan. The total premiums paid for the plan year ending 12/31/2021 were \$11,884,801.
